We will stop processing the data, except for compelling legitimate grounds or for the establishment, exercise, or defense of possible legal claims.

In cases where the processing of your data is based on your consent, you may withdraw it at any time.

Where legally applicable, you will have the right to data portability, which means that you have the right to receive the personal data concerning you that we are processing and store it on your own device; this right also allows you to request that we communicate your data to another data controller.

Likewise, if you consider that there is a problem or incident relating to the processing of your data, you may contact the entity using the contact details indicated in this document, and in any case you have the right to lodge a complaint with the Supervisory Authority for personal data protection matters, which in Spain is the Spanish Data Protection Agency (Agencia Española de Protección de Datos).
